- 1. Review the Agricultural (AG) Classification Guidelines.
- 2. Complete the Application and Return for Agricultural Classification of Lands (AG Application) AND gather all supporting documentation.

NOTE: A complete list of all criteria and documentation necessary can be found in the Agricultural (AG) Classification Guidelines.

- 3. Complete the Tangible Return Requirement Form on the back of the AG Application.
- 4. If the land is leased a Lease Agreement that empowers the lessee to file on behalf of the owner must be provided. If the lease does not empower the lessee to file on behalf of the owner a Letter of Authorization allowing the lessee to file is required.
- 5. If filing after March 1st, you must also submit a Good Cause Statement.

GOOD CAUSE STATEMENT REQUIREMENT

If you file the <u>AG Application</u> after the March 1st deadline, you MUST submit a good cause statement along with the AG application and supporting evidence indicating the reason for filing late. A good cause statement is a written statement along with supporting documentation outlining the reason for filing after the March 1st deadline. The statement should include a "verifiable showing of extraordinary circumstances," which includes: personal, family, or business crisis/emergency; or any other cause beyond the control of the applicant that would prevent a reasonably prudent applicant from timely filing.

The deadline to file for AG Classification is March 1st

The AG Application can be submitted via email to palandag@polk-county.net. You will be notified in writing on or before **July 1st**, if the AG Application is denied.

TANGIBLE RETURN REQUIREMENT FORM

Our records indicate that you own, operate, or have started an agricultural operation in Polk County. <u>Florida Statute 193.052</u> requires that all Tangible Personal Property be reported each year to the Property Appraiser's Office. Tangible personal property is everything other than real estate that is used in a business. Examples of tangible personal property (TPP) include computers, tools, machinery, signs, tractors, mowers, feeders, scales, and the like. Any supplies or equipment related to the AG operation(s) should be reported.

Every business that files an initial TPP return by April 1st is granted an exemption of up to \$25,000. If the value of your tangible assets is \$25,000 or less you do not have to file a TPP return in subsequent years. If, however, your TPP value is more than \$25,000 as of January 1st of any subsequent year, you must file a TPP return (DR-405) by April 1st of that year in order to continue to receive the TPP exemption.
